**All our training programs provide clients with employment support and retention services for up to one year after successful completion

ACE JOB PLACEMENT- Assisted Competitive Employment (ACE) provides vocational services to clients with a Mental Health Diagnosis (DSM IV-Axis I), focusing on resume preparation, interview skills, job placement, and retention support. To access ACE services, clients must submit a psychological evaluation completed and signed by a licensed clinician. To ensure a smooth and timely intake process, please include the client's psychological evaluation when submitting the referral.

EMPLOYMENT TRAINING PROGRAM (ETP) ETP offers a 10-day training focused on enhancing soft skills and digital literacy, essential for obtaining and retaining employment across various sectors. This program is tailored for individuals aiming to improve their employment and professional skills. **HS Diploma or GED are not required for ETP.**

HUMAN SERVICES TRAINING PROGRAM (HST) The Human Services Training (HST) is a 10-day training program designed to equip individuals with the essential knowledge and skills required for a career in human services. This comprehensive program addresses both soft skills and hard skills necessary for effective practice in the field. Key areas of focus: Narcan Training, Community Mental Health Certification, Crisis Prevention Skills, Boundaries and Work Ethic, Interview Prep, Digital Literacy, and Financial Literacy. Clients must have an HS Diploma or GED.

NEXT STEP INTERNSHIP PROGRAM (NSIP) The Next Step Internship Program (NSIP) is a full-time, eight-week training program that provides a combination of professional classroom and paid on-the-job training in a New York City homeless shelter or supportive housing facility. Interns gain the essential skills and experience to begin their career working with the homeless population as a Residential Aide, Front Desk/House Manager, or Maintenance Worker. This is a paid internship with a pay of \$16/hour. Clients must have an HS Diploma or GED.

____CARE CORPS: Behavioral Health Training Program-The Care Corps training program is a full-time, 6-week program designed to prepare individuals to work with patients experiencing mental illness. The program combines classroom-based learning with a hands-on, paid training opportunity at NYC Health & Hospitals simulation labs, where participants earn \$17/hour while practicing real-world skills in a structured environment. Key area of focus includes Basic Life Support (BLS) certification, Introduction to Mental Illness, Professionalism in healthcare Settings and Job Search Skills. Clients must have a HS Diploma or GED, and prior experience providing direct patient care.

____CULINARY ARTS TRAINING PROGRAM (CATP) The Culinary Arts Training Program is a comprehensive, 6-month course designed for individuals interested in pursuing a career in the Culinary Arts. The program includes 3 months of kitchen training and 3 months of practical experience through internships in a real-world culinary setting. Clients obtain their Food Handler's. **HS Diploma or GED not required.**
